Meeting Called to Order 6:01 PM

Opening Devotion: Led by Alison Betten

Agenda unanimously approved

Report Highlights:

- Staff positions have been filled. Newly called workers will be installed at association congregations GraceHill and Living Water as well as at the first chapel of the school year.
- Insurance coverage for wind and hail has dramatically increased and a buy down policy will need to be purchased as the school is not self-insured against a 1% loss.
- The Critical Response Group walk-through went well. A map of the building will be shared with law enforcement and other emergency responders.
- Trina McCollister has started working in development and will attend a razor's edge didactic session with a razor's edge expert.
- Class Intercom is a social media platform which encourages students and teachers to
 utilize social media for improving communication and updates of events within the
 school. Staff and select students and parents will be able to create content for review
 and posting by Concordia administrators.
- Concordia has enrolled one new international student since the last board meeting.
 Others attempted to enroll but could not get visas. Concordia has seven total international students enrolled for 2024-2025.

Old Business:

• Audit Update (Alison Betten):

The draft update was received and reviewed by the finance committee. A response was sent back to Dana Cole and we are awaiting their final report. Concordia will return to a more typical schedule for the 23/24 audit, which is planned to begin in August.

- Transition Committee Update (Kim Sucha):
 - The work of the organization committee is proceeding well. A meeting is scheduled for July 24 and they are hopeful that their work will be completed by the end of the calendar year.
 - Other committees have met or are planning initial meetings for August.
- Health Insurance Committee Update (Kim Sucha):

No new update - the committee meeting is set for July 29.

- Building Project Update (Nathan Domsch):
 - Concordia staff should have access to classrooms and offices on August 1st.
 August 6th will be the official date that we expect to have occupancy of those new spaces.
 - The Installation of all AV for worship art centers will not be completed by the start of school. Anticipated completion is by the end of August.
 - Chad Schwarting (BELFOR) is serving as the general contractor for the Concordia's hail insurance claim.
 - Concordia has an additional expense that stemmed from pulling lighting out of the main contract and subcontracting equipment purchases with Voss lighting.
 Voss failed to include the electrical backup for the FEMA, which will result in approximately \$38,000 in additional costs.
 - An estimated \$660,446 in additional funding will be needed to complete the project after Thrive dollars given and loan dollars.
 - The foundation is concerned with loaning money to the school.
 - Nate D. met with Dan Brown with LCEF. Using the line of credit from LCEF would be a good option at this point.
 - Use of our line of credit ideally includes a rest period (gets paid down to zero on an annual basis) but LCEF is willing to work with Concordia with this.
 - The hope is that additional Thrive campaign funds will help reduce this funding shortfall.

New Business:

- Budget Adjustment (Nathan Domsch):
 - The board supports the purchase of a wind and hail insurance coverage buy-down policy from 1% TIV per building per occurrence to flat \$15,000 deductible per occurrence for \$16,713.81 total premium

- Teacher Call (Nathan Domsch):
 - Becky Jeseritz is being contracted to cover already budgeted hours in the Academic Success Center.
 - As a former high school teacher with an LTD she is highly qualified to serve in that role.
 - Because Becky is a called church worker the district considers her called and it would be appropriate for the board to call her to this position.
 - The Board approved issuing a call to Becky Jeseritz to work in the Academic Success Center within Concordia School of Omaha.
- Review Committee Assignments (Kim Sucha):
 - Vision Committee: on hold
 - o Facilities Planning Committee: decommissioned
 - Lutheran Schools Accreditation Team: decommissioned
 - Chair Governance Committee: pending
